



## Internship Positions with The Clean Water Action Council of Northeast Wisconsin

**The Clean Water Action Council of Northeast Wisconsin is offering internship positions each semester**

A \$500 scholarship for 140 hours of activities during the semester is available, and the position has met university requirements for a three-credit internship. **As an alternative to the scholarship, UWGB students could contact Elizabeth Bloedow, student employment coordinator, for work study eligibility at [bloedowe@uwgb.edu](mailto:bloedowe@uwgb.edu)**, or 920-465-2556. Depending on the student's interests and abilities, the intern will assist the executive director with projects including encouraging sustainable environmental policy, conducting environmental and legal research, planning events, maintaining web and social media presence, community organizing, writing for the newsletter, communicating issues through film making and other media, etc. The intern will have the opportunity to attend conferences, workshops, trainings, court proceedings, and meetings with other environmental groups and environmental attorneys as scheduled during the semester. Some of these opportunities will be via virtual events.

An environmental studies or paralegal major is suggested. However, students in other majors including business, economics, and communication arts have previously benefited from the experience. The applicant should possess an interest in environmental issues and a desire to learn how small non-profit environmental organizations operate. Skills necessary for the position include general computer skills, strong reading and communication skills, and the ability to follow directions and work independently on projects. Good organizational skills with a strong work ethic will be needed for a successful internship. Additional opportunities can be tailored for individual interns.

CWAC was created in 1985 to fight toxic pollution in the Fox River and Green Bay. After many years of CWAC's sustained effort, including several lawsuits, lobbying, testifying at many public hearings, and educational programs, the Fox River PCB cleanup is now complete. Over the years, CWAC has been a leading citizens' advocacy group for environmental protection here in northeast Wisconsin. By being a party to numerous lawsuits and by bringing issues to the media, CWAC has been the voice of those often not heard, yet most affected by the environmental quality of the region. Interns have played a key role in these efforts.

Some of CWAC's current work includes education and actions to protect water resources from concentrated animal feeding operations including commenting on permits, protecting residents from emissions of air pollution, the threat of coal tar pavement sealants, monitoring and challenging air and water discharge pollution permits, identifying permit violations through field observations including use of a drone, legal actions challenging Wisconsin's administration of the Safe Drinking Water Act and the Clean Water Act, planning for and hosting health forums focused on toxins in the home and environment including PFAS concerns, water sampling at Bairds Creek, and promoting legislation to better protect human health and the environment.

**Most activities will be completed at Rose Hall office at UWGB, through online meetings, working remotely as needed, and some fieldwork.**
